**GENERAL RULES AND BATHING ESTABLISHMENT REGULATION**

1. The customer must comply with the provisions of this regulation and the ordinance in force concerning bathing establishments, displayed at the entrance of the said establishment.
2. The bathing establishment is open to the public for bathing from 8.30 am to 7.00 pm.
3. The life-guard service is provided from 9.00 am to 7.00 pm and
4. After 7.30 pm, if the customer intends to stay on the beach, he/she must ensure the closure of the umbrella in use and that he/she must remain with his/her umbrella or gazebo, and he/she is not allowed to invite other non-customers without prior authorization from the management.
5. From 2.00 pm to 4.00 pm it is strictly forbidden the use of any audio/stereo devices under umbrellas, and this period of silence must be respected.
6. Bringing and eating meals under the respected beach umbrella is permitted so long as you do not disturb other customers
7. It is forbidden to bring or keep any type of animal inside the beach area even if it is equipped with a muzzle of leash; guide dogs for the blind and for rescue are excluded from this ban.
8. Outside visitors to customers in the bathing establishment must be authorized by the management. The customer is obliged to inform his/her visitors of the internal regulations and ensure they are respected.
9. Children must be accompanied to the toilets, games area and on the beach by an adult. Adults are responsible for the behaviour of the children entrusted to them.
10. No sitting on the rescue paddle boat or on the pedalo is allowed, and children are not allowed to play on them either.
11. The Management reserves the right to remove those who cause disturbance or damage within the beach area.
12. On all beaches, following the directives of the harbour authorities, it is forbidden, apart from exceptions, to play football, racket or other games that could clearly disturb bathers, in particular along the shoreline.
13. The Management of the bathing establishment is not liable for any theft under the beach umbrella and around the perimeter of the beach.
14. It is forbidden to stand on the beach in front of umbrellas with towel and other.
15. The use of sailboards and kite surfs is not allowed
16. An umbrella can be occupied by up to a maximum of 4 adults.
17. Umbrella reservations are nominative, therefore use by third parties is not permitted
18. It is forbidden to move sun beds or chairs from one umbrella to another.
19. Dog are allowed on the terrace, see specific regulation
20. **Seasonal subscriptions must be paid no later than 15<sup>th</sup> August of each year.**

**Flag warning signs:**

- ! RED flag: "DANGER! Do not enter the water"
- ! YELLOW and RED flag: "No life-guard surveillance "
- ! YELLOW flag: "Reduced life-guard surveillance or dangerous winds"

**PARKING AREA**

1. Access to private parking is only allowed for customers of the restaurant and the bathing establishment, and in particular one vehicle per beach umbrella or gazebo, and this is subject to availability.
2. The parking area is unattended.
3. The Management declines all liability for theft and/or damage to vehicles inside the parking area.

4. In the event a customer decides to entrust his/her vehicle to a third party or even to one of our employees, he/she does so only and exclusively under his/her own responsibility, relieving the bathing establishment and its employees from any responsibility, even in the event of fault or default.

## **REGULATION FOR DOGS TO ACCESS TERRACE AREA WITHIN THE BATHING ESTABLISHMENT "IL DELFINO"**

### **ACCESS TO DOGS IS ALLOWED WITHIN THE BATHING ESTABLISHMENT PRIOR TO VISION AND ACCEPTANCE OF THE FOLLOWING REGULATION**

#### **ART.1**

Access is allowed to dogs accompanied by owner, or holder of one per companion, and/or in any case not more than one dog per umbrella's shade.

#### **ART.2**

The use of a leash and a muzzle is mandatory and is required by statute regulations.

#### **ART.3**

Owners or keepers who lead a dog, are required to use a leash or muzzle if required by the state, taking care that the dog does not dirty, cause any damage or disturbance, and in any case the length of the lease should not allow the possibility of disturbing nearby customers of the structure.

#### **ART.4**

In order to avoid liquid and/or solid excrement the person in charge is obliged to accompany the dog outside the structure at least once every hour.

#### **ART.5**

The person in charge of the animal must have suitable tools for removing dog dejections and must collect and clean them, and pay compensation for any damage caused.

#### **ART.6**

The animal must be in compliance with the prescribed vaccinations by law

#### **ART.7**

The owner relieves the structure of any responsibility for damage to persons or things caused by the animal.

#### **ART.8**

Acceptance of the animal is subject to the availability of equipment for hire, and is allowed after authorization, even verbal responsibility of the facility, and can be denied for certain business reasons and/or problems of cohesion with other customers.

#### **ART.9**

The person in charge of the structure, at his discretion, may request the immediate removal of the animal subject to reimbursement of the cost of renting the equipment for the time paid and not used.

#### **ART.10**

Access to the sea and/or the beach is not allowed.

#### **ART.11**

Animals are not allowed to climb on the equipment provided by the establishment.

**THE MANAGEMENT**
